OHSAS 18001 was developed following a large industry demand for a recognisable health & safety system that follows established best practices and protocols. Having an effective occupational health & safety management system will help turn hazards into controlled risks to create the best possible working conditions across your organisation.

Implementation involves establishing a robust framework to put in place the procedures, policies and controls needed to keep your staff and business safe. Controlling and managing risks will reduce workplace accidents and employee illness, thereby reducing associated costs and downtime.

OHSAS18001 compliance will demonstrate your organisation's commitment to safety and reassure clients and stakeholders, and can be an advantage when tendering. The standard will also ensure your organisation meets all legal requirements to help you stay within the law, minimise the risk of costly liability claims and reduce insurance premiums.

A new ISO standard for an occupational health and safety management system is being developed. ISO45001 is envisaged to replace OHSAS 18001 when it is published in late 2016.

OHSAS 18001 offers an effective, structured approach to identifying and managing potential hazards and risks in the workplace by assessing the results of risk assessment, audits, inspections, legal reviews and incident investigations and turning them into action plans.
